HIGHLIGHTS

I. Successful Applications for Competitive General Research Fund

The General Research Fund Scheme, administered by the Hong Kong Research Grants Council (RGC), awards grants to academic research projects selected through a rigorous peer-reviewed process. This year, the Institute had a 100% success rate – all three of our applicants received grants.

Dr. Ji Li (Research Assistant Professor) received HKD 627,340 for her two-year project "Making Religion, Making Local Society: The Social History of a Catholic Village in Northeast China". Dr. Li will focus on the formation, negotiation and continuity of a village's Catholic identity under the historical periods of imperialism, republicanism, colonialism and communism from the 19th to 20th century. Through examining the multi-generational history of the village, the project attempts to



illuminate a set of issues on religious identity and local elites, state building and local society, as well as Christianity and localization in modern China.

Dr. Oiyan Liu (Research Assistant Professor) was awarded HKD 217,550 for her two-year project "China's Southeast Asia: Territory, People, and Civilization in the Late Colonial Era". Her research will explore how the Chinese central state, governments and elites of Southern China, and Southeast Asian Chinese (particularly those from British and Dutch possessions) viewed Southeast Asia during its last decades of Western colonial rule. Focusing on the early 20th century, this study looks at how



European colonialism helped shape and re-shape Chinese notions of territory and people in Southeast Asia.

The Council also gave **Dr. Gonçalo Santos** (Assistant Professor) HKD 414,340 for his project "Technology, Charitable Benefaction, and Humanitarian Aid in Contemporary China". This ethnographic research will explore the rise of humanitarianism in 21st century China as a late capitalist technology of ethical imagination. Specifically, Dr. Santos will focus on the activities of two major non-governmental organizations – a



leading online charity platform and an international service club operating in the South China

region – and give particular attention to the relationship between ethical subjectivities, technological infrastructures, and political economy. The two-year project joins recent efforts in the humanities and social sciences to emphasize the increasing importance of ethical regimes of charitable giving in the formation of contemporary subjects and in the legitimation of mounting social inequalities.

In addition to our full-time colleagues, **Dr. Izumi Nakayama** (HKU), Honorary Assistant Professor of the Institute and Assistant Professor at the Department of Japanese Studies, obtained HKD 328,620 from the Council for her three-year historical and ethnographic study "Be Polite, Be Healthy, Be Feminine: Gender, Body Culture, Etiquette, and Health in Modern Japan".

II. Successful Applications for the Competitive Hong Kong PhD Fellowship Scheme

A total of 223 Hong Kong PhD Fellowships were granted in the 2014/2015 admissions cycle for all disciplines in eight participating tertiary institutions. All three PhD students recruited by the Institute this year have been awarded the prestigious fellowship, amounting to another 100% success rate. The scheme was established by the RGC to attract outstanding students from around the world to pursue doctoral studies in Hong Kong. CORE PROGRAMS AND EVENTS

I. Multi-Year Research Clusters

With the recent recruitment of young talents, we are entering a new development phase solidly based on bigger and better structured research teams. Three major clusters under the overarching theme of "Inter-Asia Connections" are now in place.

1. Science, Technology, and Medicine in Asian Societies



Led by Prof. Angela Leung (HKIHSS, HKU), Dr. Gonçalos Santos, and Dr. Izumi Nakayama, the "Science, Technology and Medicine in Asian Societies" (STMS) cluster will challenge deeply entrenched ideas about the autonomy of science and technology. The team concentrates on three overarching themes: 1) institutions, policies, and economy; 2) gender, daily life, and material culture; and 3) construction, transmission and circulation of knowledge, skills, and practices. Priority is given to the question of the formation of modern scientific, medical, and

technological cultures in Asia, with a special focus on China. Research in this field will shed new light on the role played by science, technology and medicine (STM) in the building of modern Asian societies, and on how this process of appropriation of STM is embedded in broader socio-cultural and politico-economic dynamics.

In May 2014, the cluster established the STM Working Group that involved scholars based in Hong Kong and the Pearl River Delta as a response to similarly established and growing research teams in the United States and elsewhere in Asia to promote the study of STM. As its first initiative, the group will coordinate the Science, Technology, and Medicine in Societies Colloquium Series in December 2014. This series intends to build a global network of scholars whose research focuses on developments in the field of science, technology, and medicine in China and Asia. Invited speakers will address critical problems of the 21st century from diverse intellectual frameworks and perspectives.

In addition, the cluster will also co-organize the "International Conference on Food and Health" with the Asian Society for the History of Medicine in December 2014. The event is generously sponsored by the Chiang Ching-kuo Foundation for International Scholarly Exchange, the

Strategic Research Theme in China-West Studies under the University of Hong Kong's Faculty of Arts, and the D. Kim Foundation for the History of Science and Technology in East Asia. Looking further ahead, the cluster is preparing an application for the Collaborative Research Fund Scheme administered by the RGC, to be submitted in early 2015.

2. Hubs, Mobilities and the Asian Urban

The "Hubs, Mobilities and the Asian Urban" cluster is directed by Prof. Helen Siu (Yale University & HKU) and Prof. Richard Wong (HKU). The cluster examines the historical and contemporary

urban in an inter-connected Asia by treating urban and national spaces not as coherent, bounded analytical units, but as "assemblages" encompassing open, interactive, contingent and multi-scalar historical processes. Specifically, it will focus on a few world cities across the Asian region that are connected and inter-referenced with deep historical baggage, yet are striving to distinguish itself from one another under



volatile, competitive pressures. The team tracks the cities' "art of hubbing" – local, regional and global positioning – and captures the lived experiences of their population. The cluster also looks closely at how these cities engage the tumultuous modern transformations of Asia in the past century and the urban renaissance of the new century.



The foundation of this cluster was laid by several projects supported by the Institute – the "Trading Empires of the South China Coast, South Asia and the Gulf Region" cluster, the "Environmental Sustainability, Political Ecology and Civil Society" cluster, the "Global Cities and Social Life of Finance Capital in Asia" cluster, the "Hong Kong Memory Project", and a research proposal

"The Art of Hubbing" which was among the finalists in the 2011 Theme-based Research Scheme (TRS) selection. In the reporting year, these projects organized conferences and training programs (e.g. "Ecologies of Urbanism in Asia II", and "Advanced Training Program on Urban Study and the China Experience"). They also produced book series and edited volumes, which

included *Asia Inside Out* by Harvard University Press and *Ecologies of Urbanism in India: Metropolitan Civility and Sustainability* by HKU Press.

The cluster has planned a brain-storming workshop in Spring 2015 to discuss the re-organization of the team for the preparation of a TRS application. This workshop will be followed by the formation of three research groups, exploring historical Asian urbanity, contemporary Asian urbanity as well as physical mobility and social immobility in Asian cities.

3. Rethinking Spirituality and Religion in Asia

Directed by Dr. David A. Palmer (HKU), this cluster has been established on the emerging scholarly consensus that the complexity of religious realities and issues in Asia requires a rethinking of the concept of religion and its relationship to the rest of society. The goal of this cluster is to promote the emergence of a trans-Asian conversation on religion in Asian societies. By taking this perspective, this cluster aims to bring significant theoretical and



methodological contributions to the humanistic and social scientific study of religion.

The cluster is built on four areas of research and collaboration development by Dr. Palmer over the past decade – 1) Chinese religion and modernity in a global context; 2) the ethnography of religion in traditional Chinese community; 3) religion, spirituality and healing; and 4) spirituality, faith-based NGOs and social engagement.


Several cluster events have been planned for the 2014-2015 academic year. These include a roundtable seminar on "Comparing Indian and Chinese Philosophy and Religion: Reflection and Prospectus" as well as the conference on "Text and Context: Redemptive Societies and New Religious Movements in Modern and Contemporary China and Southeast Asia" in Fall 2014. The latter will bring together scholars from Germany, the United Kingdom (UK), Canada, mainland China, Taiwan, Japan, Malaysia, Brunei and Singapore for discussions on the growth, development and revival of socioreligious groups such as the Yiguandao, the Daoyuan, the Tongshanshe and the Wushanshe beginning from the Republican period.

Aside from the aforementioned, the Institute's existing clusters continue to carry out its activities while being re-organized and integrated under the new clusters.

4. East Asian Medicine, Science and Contemporary Public Health

Led by Prof. Angela Leung and Dr. Izumi Nakayama, this project takes a comparative approach to colonial medicine and its implications for medical culture in the contemporary society. A book volume, **Gender, Health and History in Modern East Asia**, which follows up on the workshop "Anatomical Modernity: Gender & Health in East Asia" convened in June 2013, is currently under review for publication.

5. Trading Empires of the South China Coast, South Asia and the Gulf Region



Principal investigators and editors Prof. Helen Siu and Prof. Eric Tagliacozzo (Cornell University) have been working on a three-volume series "Asia Inside Out" with Harvard University Press and core co-investigator Peter Perdue (Yale University). The first book Asia Inside Out: Changing Times is due to be published in January 2015. The second volume, "Connected Places", and the third, "Mobile Peoples", are soon to follow. The team has also planned a third workshop cum fieldtrip for 2015. This final meeting will focus on people and processes.

6. Environmental Sustainability, Political Ecology and Civil Society

An edited volume *Ecologies of Urbanism in India: Metropolitan Civility and Sustainability* by principal investigators, Prof. K. Sivaramakrishnan (Yale University) and Prof. Anne Rademacher (New York University) was published by HKU Press in 2013 following the first conference on "Urban Ecologies of Asia". A second conference, "Ecologies of Urbanism in Asia II: Cities, Towns, and the Places of Nature" was held by the cluster from June 9 to

12, 2014. The event was held at HKU over a four-day period and involved 31 participants from

various top institutions in Asia, Europe and North America. Participants also went on field trips in Hong Kong and Macau to gain a better understanding of the historical development of urban spaces in the region and investigate issues of ecological sustainability. Full conference program is in <u>Appendix I</u>. A follow-up workshop has been planned for early 2015 at Yale University.

II. Global and Multi-year Partnerships on Research Training

As in previous years, the Institute has partnered different international institutions to engage in a variety of research projects and activities.

1. Social Science Research Council and National University of Singapore

Since 2010 the Institute has been collaborating with the Social Science Research Council (SSRC) and the National University of Singapore (NUS) to organize international conferences under the "Inter-Asian Connections" program. This year, the three parties were joined by Yale University and Göttingen University to hold "Inter-Asian Connections IV: Istanbul". The conference was hosted

by Koç University from October 2 to 5, 2013 and many leading scholars, including Willem van Schendel (University of Amsterdam), Deniz Kandiyoti (The School of Oriental and African Studies), Erik Harms (Yale University), Helen Siu (Yale University and HKU), Michael Feener (NUS), Prasenjit Duara (NUS), participated. Also present were Dr. Lawrence Zhang (HKIHSS, HKU) and Dr. Chris Munn (HKU Press) who attended with support from the Institute. The conference hosted seven concurrent workshops showcasing innovative research that focused on Asia reconceptualized as a dynamic and interconnected historical, geographical, and cultural formation stretching from the Middle East through Eurasia and South Asia to East Asia. On the last day, all participants reconvened for a public presentation and exchange of research agendas that had emerged over the course of conference deliberations. 2. The Association for Asian Studies

The Institute entered into an agreement with the Association for Asian Studies (AAS), the National University of Singapore (NUS), Academia Sinica and Doshisha University in 2012 to co-organize a series of conferences on "Asia in Motion" in Asia. The inaugural conference of the series was hosted by the Asia Research Institute and NUS from July 17 to 19, 2014 under the theme of "Heritage and Transformation". A total of 80 panel sessions were held concurrently over a three-day period, with papers on subjects covering a wide range of scholarly disciplines and encompassing all regions of Asia. Topics ranged widely from political and economic changes, literary and cultural expression, environmental sustainability, media and pop cultural production, food and energy policy, new models for Asian enterprise and business, as well as issues of globalization and urban growth. Professors Dipesh Chakrabarty (University of Chicago) and Pasuk Phongpaichit (Chulalongkorn University) gave keynote addresses at the event, which also included a roundtable, workshop and walking tours of Singapore. Professors Helen Siu and Angela Leung of the Institute served as chairs and discussants in two panels of the conference. The next conference will be organized by Academia Sinica in Taipei from June 22 to 24, 2015.


3. Harvard-Yenching Institute and East China Normal University

"Urban Studies and the China Experience" is a series of advanced training workshops jointly organized by the Institute, the Harvard-Yenching Institute (HYI) and East China Normal University (ECNU) over three years. The program was established in 2011. The program held its final event between August 18 and 24, 2014 at The University of Hong Kong.

This seven-day training workshop involved 20 postgraduate students and young scholars from mainland China, India, Taiwan, Japan, Europe and the United States (US). A series of activities including presentations, city walks as well as a documentary film screening were organized, and

renowned scholars such as Professors You-tien Hsing (University of California, Berkeley), Angela Leung (HKU), Peter Rowe (Harvard University), Helen Siu (Yale University & HKU), Eric Tagliacozzo (Cornell University), Jishun Zhang (ECNU), and May Bo Ching (Sun Yat-sen University) were invited to give lectures based on the theme "Inter-Asian Urbanity: Connections and Comparisons". At the conclusion of the program, a small number of outstanding individuals will be selected to spend a year in residency as a visiting scholar at the Harvard-Yenching Institute in Cambridge, Massachusetts. (See <u>Appendix III</u> for the program) The Institute will continue to work with the HYI and two major Chinese universities on a new training workshop series beginning in 2015.

4. Yale University

Yale University continues to provide the Institute with invaluable support each year. During the recent academic year, Prof. K. Sivaramakrishnan served as co-convener of the "Environmental Sustainability, Political Ecology and Civil Society" cluster, and Prof. Helen Siu took up the role of co-convener of the "Hubs, Mobilities and the Asian Urban" cluster.

Prof. Siu is visiting the University as the Mok Hing-Yiu Distinguished Visiting Professor from December 2013 to December 2014. Besides developing the new "Hubs, Mobilities and the Asian Urban" cluster with Prof. Richard Wong (HKU), she offered a postgraduate seminar course "Research in Sociocultural Anthropology: Design & Method" in the spring semester of 2014.

5. The Asian Society for the History of Medicine

In association with the Asian Society for the History of Medicine, the "International Conference on Food and Health" will take place in Hong Kong in the winter of 2014. Three themes – "Nutrition and Body", "Food as Product/Poison/Cure", and "Hunger and Famine" – have been identified with the purpose of examining the link between what we consume and our body's health in the Asian context. Six panel sessions have been planned for the two-day event and participants include scholars from various parts of Asia, Germany, France and the US. Prof. Francesca Bray, Professor of Social Anthropology at the University of Edinburgh will be the conference's keynote speaker.

6. Sun Yat-sen University

Another of our longstanding partnerships is with the Sun Yat-sen University (SYSU) in Guangzhou, and in particular, its History Department, the School of Asia-Pacific Studies and the Centre for Historical Anthropology. For over a decade, we have worked together to produce the acclaimed Journal of History and Anthropology (歷史人類學刊), the History in the Field (歷史·田野叢書) monograph series, and the **Historical**



Anthropology Lecture Series. More about the lecture series will be found on p. 15 under "Lectures, Seminars and Workshops".

During the reporting period, the Institute and the Centre for Historical Anthropology at SYSU organized a training program "Historical Anthropology: The History and Development of Guangzhou" (歷史人類學考察項目: 廣州歷史及其當代發展) from November 22 to 24, 2013 for 17 undergraduate and 2 postgraduate students from HKU.

The trip to Guangzhou was part of the HKU-China 1000 Exchange Scheme supporting HKU students to visit mainland China. Participants had the opportunity to attend lectures, visit

places of historical significance, and have exchanges with local youths and members of student organizations. Through this positive experience, many benefitted from acquiring a different perspective about Guangzhou, its people and its relationship with Hong Kong. (See <u>Appendix IV</u> for the workshop program)

Both institutions then coordinated the **Eleventh Advanced Summer Training Workshop in Historical Anthropology** (第十一屆歷史人類學高級研修班) held from July 17 to 28, 2014. It gathered 22 scholars and postgraduate students who travelled to Singapore and Malaysia to learn more about overseas Chinese societies. Fieldwork was conducted in a number of locations including Singapore, Malacca, Penang, Perak and Port Klang, with intense discussions following each session. IV. Institutional Development

During the reporting year, several significant institutional developments further bolstered the Institute's postgraduate program.

1. Institutional Enhancement Scheme

Established in 2013, the **Institutional Enhancement Scheme** is a scheme made possible by a generous donation from the Lee Hysan Foundation to help nurture HKU students. Through the Scheme, the Institute is also able to invite world-renowned scholars to visit the University for up to a semester.

Prof. Francesca Bray, Professor of Social Anthropology at the University of Edinburgh will visit the Institute in the fall semester of 2014 and teach a course on "Techno-cultures: A Cross-disciplinary Exploration" with Dr. Gonçalo Santos. On top of her teaching responsibilities, she will speak at the Ninth Needham Memorial Lecture as well as the "International Conference on Food and Health". Next year, we look forward to hosting Prof. Ronnie Hsia, Edwin Earle Sparks Professor of History at Pennsylvania State University, and Prof. Dorothy Ko, Professor of History at Barnard College, Columbia University.


Also formed out of the Scheme is the **Lee Hysan-HKIHSS Fellowship**, which gives HKU students the opportunity to go on academic exchanges overseas to learn under the tutelage of esteemed scholars. 2. Postgraduate Program and Recruitment of New Students



3. Sin Wai-Kin Junior Fellow Program

Thanks to the generous donation from Dr. Wai-Kin Sin, the Institute set up the Sin Wai-Kin Junior Fellow Program in 2011 to offer financial and academic assistance to junior colleagues and/or PhD students for their research. Dr. Izumi Nakayama, Dr. David A. Palmer and Mr. Brian Hsieh have been appointed Sin Wai-Kin young fellows. Dr. Nakayama is now Co-Principal Investigator of the Collaborative Research Fund project that the Institute is building. Dr. Palmer now directs one of the three new research clusters of the Institute.

4. Further Integration with the University


The Institute has started promising discussions with the Faculty of Arts on sharing ladder positions that would organically link the Institute with the faculty and strengthen as well as sustain research synergies.

V. Publications

Another pillar of the Institute's work is publishing. The Institute recognizes its value and regularly supports the publication of research results into books and journal articles. This assistance takes various forms, including the provision of academic, financial and promotional facilities. A considerable portion of the output is generated from the work of our research clusters as well as full-time and honorary colleagues.

1. Books and Journals Supported by the Institute

This year, the Institute supported the book project *Wives, Husbands, and Lovers: Marriage and Sexuality in Hong Kong, Taiwan, and Urban China* (Stanford University Press, 2014).



Chronicling transformations in perception and practice of sexual relationships and marriage across various urban settings in China, Hong Kong, and Taiwan, Professors Deborah S. Davis and Sara L. Friedman (eds.) investigated how the marital "rules of the game" have changed substantially since the 1980s. The chapters in this volume were collected from papers presented at the "International Workshop on Marriage in Cosmopolitan China" organized by the Institute in 2011, with contributions from our colleagues Dr. Jun Zhang (HKIHSS, HKU) and Dr. Petula S.Y. Ho (Social Work and Social Administration, HKU).

In addition, the Institute supports the *History in the Field* monograph series (歷史‧田野叢書) and the *Journal of History and Anthropology*. The latter is one of the Institute's key publications and is published bi-annually by the Institute, the Centre for Historical Anthropology at Sun Yat-sen University, and the South China Research Centre at the Hong Kong University of Science and Technology (HKUST). It is currently running into its 23^{rd} issue this year and features diverse articles and book reviews with cross-disciplinary perspectives in history and anthropology.



VI. Knowledge Exchange

Our commitment to reaching out to members of the community, engaging and informing them on relevant issues in the Asia region, makes knowledge exchange one of the Institute's priorities. Our main efforts are the Contemporary Chinese Documentary Series and different research projects.

1. Contemporary Chinese Documentary Series

At each session of the **Contemporary Chinese Documentary Series**, we showcase an inspiring film by a director from the region that spotlights certain pressing socio-economic, political, and cultural issues. At the same time, it provides an occasion where audiences and filmmakers can interact and exchange ideas and opinions. The documentary screenings have been very well-received. 2. Hong Kong Memory Project

The **Hong Kong Memory Project** is Hong Kong's response to UNESCO's Memory of the World Program. Led by Prof. Elizabeth Sinn and sponsored by the Hong Kong Jockey Club Charities Trust, the project has created a digital repository of Hong Kong's history, culture and heritage. These online records serve as educational materials and can be accessed both locally and from overseas at www.hkmemory.hk. Additionally, the project has also launched various outreach and engagement events, such as exhibitions, community programs (e.g. the "School Memories" project and "Our Digital Stories" program) and sharing sessions. As the project enters its final stages, it has been given an additional extension until November 30, 2014, before it will be handed over to the Leisure and Cultural Services Department of the HKSAR Government.

3. Documenting the Oral History of Overseas Chinese in Cuba

Documenting the Oral History of Overseas Chinese in Cuba is a research project funded by the Lee Hysan Foundation and conducted by Dr. K.S. Louie, Honorary Research Associate of the Institute. The primary objective of this 20-month project is to record and document the oral history of overseas Chinese still living in Cuba today. Its impetus has been the rapid decline in the overseas Chinese population in Cuba. With many approaching their twilight years, there is a

need to detail – before it is too late - the unique history and memory of this group of Chinese migrants, who have lived in relative isolation since the Cuban Revolution.

Dr. K.S. Louie has travelled to six different cities in Cuba – Havana, Camaguey, Ciego de Avila, Santa Clara, Trinidad, and Cienfuegos – and conducted more than 30 interviews with first- and second-generation Chinese there. Using the materials he has compiled and collated, he has produced a 150-page written report in addition to building an archive of interview transcripts, photographs, as well as voice and video recordings. He has also written a series of articles

and short essays published in various print media (e.g. the *Hong Kong Economic Journal, Apple Daily*, the *Hong Kong Film Archive Newsletter*), and has spoken on the history of Chinese in Cuba on several public occasions.

Dr. K.S. Louie's work has simultaneously attracted the attention of Radio-Television Hong Kong (RTHK) and the Hong Kong Museum of History. The former invited him to join in the filming of a documentary on the overseas Chinese in Cuba, while the latter commissioned him to carry out additional research related to the trade of Chinese coolies to Cuba in the 19th century. Moving forward, plans are underway to make this valuable repository available to students and the scholarly community.

4. Preserving the History of the Southern District, Hong Kong

Since the last quarter of 2013, Dr. Wai Ling Wong (HKIHSS, HKU) has led a project to document and share the history of traditional fishing communities in Aberdeen. This is a collaboration jointly run by the Institute and the University's Centre of Development and Resources for Students (CEDARS), and part of the **We Are With You (WAY) Project** funded by the Chow Tai Fook Charity Foundation. Over 20 HKU undergraduate students have been recruited to help the local community preserve and turn its rich culture and history into social capital. They learned how to conduct oral history interviews and communicate life stories of the fishing communities subsequently through public programs such guided tours.
