#### Book Webinar by Prof. Gungwu Wang



The Institute and the HKU Government and Laws Committee (GLaws) jointly invited Prof. Gungwu Wang, Fellow of HKIHSS and University Professor of the National University of Singapore, to give a webinar on his books, *Home is not Here* and *Home is Where You Are*, on April 21, 2021. In this fascinating, one-and-a-half-hour talk, Prof. Wang shared with over 300 audience members his life journeys in Malaya and China, as well as stories featuring his late wife Mrs. Margaret Wang, reflecting on the ideas of family, identity, and one's sense of belonging.

# Congratulations to Prof. David A. Palmer for obtaining RGC General Research Fund (2021-2022 Exercise)

Prof. David A. Palmer has been awarded HK\$776,709 for a 36-month project entitled "Rituals and Manuscripts of the Lanten Yao (Yao Mun)." The project will bring together expertise in anthropology, sinology, history, and manuscript studies in China, Laos, and Vietnam. The project will transcend national boundaries that fragment the study of ethnic minorities in continental Southeast Asia, and significantly advance the study of Daoism among non-Han, non-Chinese ethnic groups.




#### 3. Hubs, Mobilities and the Asian Urban

#### 4. CRF Project "Making Modernity in East Asia: Technologies of Everyday Life, 19<sup>th</sup>-21<sup>st</sup> Centuries" (MMEA)

#### **Online Dialogue "Soy Sauce Across Asia: Tradition, Taste, and Technology"** (May 27, 2021)

Prof. Angela Ki Che Leung, together with Dr. Izumi Nakayama, Dr. John D. Wong, Dr. Hallam Stevens (Nanyang Technological University), and Mr. Daniel Chan, a soy sauce maker from Hong Kong's Koon Chun Sauce Factory, discussed the history of soy sauce and examined the differences and similarities across production methods in Singapore, Hong Kong, China, and Japan. The discussion revolves around the view that the development of soy sauce can be used to map and track the technological and industrial development, globalization, as well as the heritage value of food.



#### **Religion and Empire Lecture Series**

Six Zoom lectures were organized in the first half of 2021. The invited speakers spoke on the entanglements between religion, infrastructure, and empire in the past and present. The cases covered locations from Rio de Janeiro to Nepal to Tokyo, all of which being connected to China through networks intertwined with religion, diplomacy, migration, or infrastructure. 




## **OUR POSTGRADUATE PROGRAMS**

Dr. Andrea Chen (PhD graduate, 2021) is teaching at the Divinity School of Chung Chi College, CUHK, as Parttime Lecturer.


